What data do we collect?

We collect the following data:

- Personal identification information (Name, email address, phone number, etc.)
- IP address (we may also derive your approximate location from your IP address)

How do we collect your data?

You directly provide us with most of the data we collect. We collect data and process data when you:

- Subscribe to our newsletter
- Fill our contact box on our website
- Contact us via email
- Apply for a job through our website
- Use or view our website via your browser's cookies

How will we use your data?

We collect your data so that we can:

- Email you with our latest news and updates
- Contact you regarding your request you have submitted to us
- Contact you regarding your job application

How do we store your data?

We take appropriate measures to store your data securely. Only authorized persons with a justified need will access our databases containing personal information.

We will keep your personal identification information for up to one year. Once this time period has expired, we will delete your data by using appropriate measures, unless there is a legal obligation to which we are subject that requires us to keep your data for a longer time period.

Marketing

Our Company would like to send you information about products and services of ours that we think you might like.

If you have agreed to receive marketing, you may always opt out at a later date.

You have the right at any time to stop us from contacting you for marketing purposes.

What are your data protection rights?

We would like to make sure you are fully aware of all of your data protection rights. Every user is entitled to the following:

The right to access – You have the right to request copies of your personal data.

The right to rectification – You have the right to request that we correct any information you believe is inaccurate. You also have the right to request we complete the information you believe is incomplete.

The right to erasure – You have the right to request that we erase your personal data, under certain conditions.

The right to restrict processing – You have the right to request that we restrict the processing of your personal data, under certain conditions.

The right to object to processing – You have the right to object to our processing of your personal data, under certain conditions.

The right to data portability – You have the right to request that we transfer the data that we have collected to another organization, or directly to you, under certain conditions.
